#### 5. Trustee Updates:

**Deputy Mayor Collopy:** Reported Roadrunners Marathon has been cancelled.

- **7.** Harts Village Retaining Wall: Mayor Brown explained that Tectonic of Newburgh came in with the low bid at \$1,665.00 and were recommended by Delaware Engineering to do the testing for the Harts Village Retaining Wall. *Motion* made by Trustee McGrane to award the bid to Tectonic, seconded by Deputy Mayor Collopy and all were in favor.
- **8. LOSAP**: *Motion* made by Trustee Herzog allowing Mayor Brown to sign off on the LOSAP paperwork, seconded by Trustee McGrane and all were in favor.
- **9.** Crack Repair at Tennis Court: Mayor Brown explained Myndi Hill, Village resident, offered to power wash and fill the cracks at the tennis court with the help of some additional volunteers. He said the Village will be paying for the materials as long as it doesn't exceed \$500. *Motion* made by Mayor Brown to allow Myndi Hill to move forward with the tennis court project, seconded by Deputy Mayor Collopy and all were in favor.
- **10. Split Village Tax Bill:** Mayor Brown said he would be forwarding the information he received on splitting the tax bills into two payments to the Village Board. Mayor Brown explained to the Board some of the information he has received. He asked the Board to please review information he will be sending out and respond with "Aye" or "Nay" on splitting the bill.
